## Application for Membership – Notes for Guidance

### **RULE 10. Ordinary Membership**

Candidates over the age of 18 may be elected to Ordinary Membership by:-

- (a) a majority of Ordinary Members present and voting at any General Meeting of the Club, or
- (b) by a majority of Council members present and voting at a Council Meeting.

The candidate must be proposed and seconded by two Ordinary Members, of whom one must have been a member for at least five years, and the either of whom must be a Resident Member.

In addition, the candidate must be supported in his application by two referees, of whom one must have been a member for at least five years, and either of whom must be a Resident Member.

The completed Application must be forwarded to the Secretary at least two weeks prior to the meeting at which it is to be considered (Council meetings are held on the last Friday of each month) . The Secretary shall display the names of all applicants in a conspicuous place in the Clubhouse for at least one week before the relevant meeting..

Members elected shall enjoy equal rights and privileges and be subject to the same Rules and obligations as existing Ordinary members.

### **RULE 11. Junior Membership**

Candidates under the age of 18 may be admitted to junior membership at the discretion of the Council. Junior Members resident within 15 miles of the Clubhouse will, before making payment of their entrance fee and/or annual subscription, satisfy the Council that they have paid the annual green fee to the appropriate authority controlling the management of the Carnoustie Golf Courses.

On attaining 18 years of age, Junior Members shall be permitted to order and consume alcoholic liquor and use the gaming machines within the Clubhouse.

On 1<sup>st</sup> February next following their 18<sup>th</sup> birthday they shall be enrolled as Youth Members and shall continue in this category until 1<sup>st</sup> February next following their 22<sup>nd</sup> birthday. As Youth and Ordinary Members they shall then be liable for the annual subscription at the appropriate rate, and shall be entitled to take part in the business and affairs of the Club. They shall also enjoy equal rights and privileges and be subject to the same Rules and obligations as existing Ordinary members.

**The granting of membership is at the sole discretion of the Ordinary and/or Council Members present and voting at the meeting before which the Application is laid, and the Club will be under no obligation to provide reason or explanation for any application which is not so granted.**
